# GAIT ANALYSIS AND RECOGNITION



- Under forensic science, gait is studied through forensic gait analysis which includes the identification of gait features and patterns of subjects seen on CCTV and from footprints forming a gait pattern left at the scene of a crime.
- The height of an individual can be determined by his/her footprint and shoe print, as the foot tends to be approximately 15 % of the person's average height.
- Footprints are left at the scene of a crime forming a recognizable gait cycle.
- The most studied gait features since 1970s is the lower limb, as the leg motion can be effectively used as a cue to identify a person.
- Gait recognition techniques :
  - Automatic analysis of Video Imagery
  - Radar System
